REGULATIONS ON RADIO FREQUENCY SPECTRUM FEES IN TERMS OF THE ELECTRONIC COMMUNICATIONS ACT, 2005 (NO. 36 OF 2005)

**AMENDMENT OF THE RADIO FREQUENCY SPECTRUM FEES, 2010 IN TERMS OF
THE ELECTRONIC COMMUNICATIONS ACT, 2005 (ACT NO. 36 OF 2005)**

The Independent Communications Authority of South Africa has, under sections 4(1) of the Electronic Communications Act, 2005 (Act No. 36 of 2005), made the regulations in the schedule.

SCHEDULE

1. Definitions

In these regulations “the Regulations” means the regulations published by Government Notice No. 33495 of 2010, as amended by Government Notice No. 280 of 2015.

2. Amendment of regulation 1 of the Regulations

2.1 Regulation 1 of the Regulations is hereby amended by the substitution, after the definition “KHz”, of the following definition:

““MHZ” means a radio frequency value designated in megahertz”.

2.2 Regulation 1 of the Regulations is hereby amended by the addition, after the definition “Minimum Fee”, of the following definition:

““SEC” means Security Factor.”

3. Short Title and Commencement

These Regulations are called the Radio Frequency Spectrum Licence Fee Amendment Regulations, 2015 and will come into force upon publication in the Government Gazette.
