The Independent Communications Authority of South Africa ("the Authority") hereby invites applications for Digital Community Television Broadcasting Service and Radio Frequency Spectrum Licences on MUX 1 frequencies in terms of the provisions of section 17 of the Electronic Communications Act, 2005 (Act No. 36 of 2005), as amended ("the EC Act") read with regulation 4(5) of the Community Broadcasting Services Regulations, 2019, regulation 4 of the Promotion of Diversity and Competition on DTT Regulations, 2014 and read with regulation 7 of the Radio Frequency Spectrum Regulations, 2015.

All applications will be considered based on the requirements of this Invitation to Apply to Pre-Register ("ITP-R"), the applicable regulations developed by the Authority and the EC Act.

This ITP-R applies to both the service and spectrum licence applications.

**SCHEDULE A: APPLICATION GUIDELINES IN RESPECT OF THE  
SERVICE LICENCE AND RADIO FREQUENCY SPECTRUM  
LICENCE APPLICATIONS**

1. Applications must be made in writing, in the format set out in this ITP-R.
2. Applicants must answer all questions set out in the application form in full. If any question is considered not applicable, mark it as "N/A" and provide further explanation as to why it is not applicable.
3. Applicants must submit one original application, clearly marked as such, together with five (5) hard copies, and one (1) soft copy of the application, all of which must be received by the Authority by the closing date indicated in paragraph 14 below.
4. All applications, subject to Schedule C below, submitted to the Authority pursuant to this ITP-R will be made available for inspection by interested persons. Copies of the applications will be obtainable at the Authority's library upon payment of a fee as may be determined by the Authority from time to time.
5. Each application must be permanently bound (using either heat or spiral binding).
6. Each application must have a cover page indicating the title of the ITP-R, name of the Applicant, the proposed name of the broadcasting service licensee and year of application.
7. The page(s) immediately following the cover must be the contents page(s), which shall detail each section of the application and corresponding page numbers.
8. The entire application, including the appendices and schedules, must be sequentially numbered starting with the page immediately following the contents page(s) as page 1 and ending with the very last page of the application.
9. In the event that the Applicant has to submit its application in more than

one part or volume, each part or volume must have a cover page bearing all the details set out above. In this case the cover page must specify the number of the part or volume (i.e. Part One, Part Two or Volume One, Volume Two). Each volume or part must also have the full set of contents pages and be sequentially numbered as indicated above.

10. Applicants must apply for the assignment of Multiplex 1 broadcasting frequencies as specified in Schedule J of this ITP-R.
11. The Authority reserves the right not to award frequencies should applicants not meet the requirements as set out in this ITA.
12. An applicant must commit not to engage in any activity, which would or could be construed as an illegal or corrupt practice, either directly or indirectly. Any such practice will be grounds for disqualification.
13. Applications must be addressed for the attention of the General Manager: Licensing and must be deposited into the box designated for that purpose at Block B, Eco Point Office Park, 350 Witch-Hazel Avenue, Eco Park, Centurion, Pretoria.
14. The closing date for the submission of applications shall be 11:00 am, South African time, on 04 November 2020.
15. **Applications received after the closing date and time will not be accepted or considered by the Authority.**
16. The licensing process will be undertaken in two phases:
  - 16.1. Phase 1: Consideration of the applications for pre-registration of Community Television Broadcasting Service licence and DTT Multiplex 1 frequencies;
  - 16.2. Phase 2: Consideration for registration of the community TV broadcasting service licence.
    - 16.2.1 The successful applicants from the pre-registration process will be required to pay the non-refundable application fee of three thousand, eight hundred and twenty-eight rand

17. This licensing process will culminate in the issuing of the 15% maximum capacity on DTT Multiplex 1 per Province as indicated in the table below. Additional broadcasting service licences may be issued to community television broadcasting services to make up a 15% maximum capacity on DTT Multiplex 1 per Province where there is already assigned community broadcasting services in the Province.

18. In addition to the terms and conditions set out in this Schedule, Applicants are advised to appraise themselves fully with the provisions of the EC Act, ICASA Act, Broadcasting Act and all relevant regulations promulgated by the Authority that may be applicable to this ITP-R.
19. All applicants shall carry their own costs in responding to the ITP-R.

- 20. The Applicant must submit proof that it is a Non-Profit Organization that has been in operation for a period of two (2) years or more.

**SCHEDULE C: REQUESTS FOR CONFIDENTIALITY**

1. In terms of section 4D of the ICASA Act, Applicants may request that any part of the application be treated as confidential. The request for confidentiality must be made in terms of section 4D of the ICASA Act and should be accompanied by a written statement explaining why the specific information should be treated as confidential. Also see ICASA Guidelines for Confidentiality request published in Government Gazette No. 41839 (Notice No. 849) published on 17 August 2018.
2. Confidential information documents must be clearly marked as such and submitted together with the original application, comprising the original thereof, five (5) hard copies and one (1) soft copy.
3. Request for confidentiality will be considered within fourteen (14) working days of receiving the request and the Authority will communicate its decision to the respective Applicant.
4. In the event that the request for confidentiality is refused, the Applicant may choose to withdraw the information on which confidentiality is requested.

**SCHEDULE D: AMENDMENTS TO THE APPLICATION**

1. Amendments to applications received in terms of this ITP-R will be considered in terms of the provisions of Form B of the Class Licensing Processes and Procedures Regulations, 2010 as amended.
2. In instances where the information included in an application changes at any time after submission of the application but before the Authority makes a decision, the Applicant must apply to the Authority for amendment of the application, in writing within fourteen (14) days of such change.
3. The Authority will, after considering the amendment application, determine whether the changes:
  - 3.1. unfairly prejudice other interested parties;
  - 3.2. impede the expeditious and proper consideration of the application; or
  - 3.3. materially change the application as to constitute a new application.
4. The Authority will then notify the Applicant of its decision to either grant or refuse the amendment application. In the event that the amendment application is granted, the Authority may publish a notice in the Government Gazette inviting interested parties to submit written representations in relation to the amendment application within the period stipulated in the notice.

**SCHEDULE E: REQUEST OF SUBMISSION OF SUPPLEMENTARY

  - 1.1. submitted an application but is an affiliate of another Applicant within the same application process; or
  - 1.2. capacity already assigned to it or its affiliate in Multiplex 1; or
  - 1.3. submitted more than 1 (one) application to the Authority in response to this ITP-R; or
  - 1.4. submitted an application which contains false or misleading information; or
  - 1.5. colluded or attempted to collude with another Applicant; or
  - 1.6. obtained or acquired confidential information relating to another Applicant without consent from the Authority and/or the owner of such confidential information; or
  - 1.7. failed to comply with the terms and conditions of the ITP-R, the provisions of the EC Act, ICASA Act, Broadcasting Act and/or all relevant Regulations; or
  - 1.8. submitted an incomplete application.

## 6. WITHDRAWAL OF RADIO SPECTRUM LICENCE

6.1	Failure to meet fifty percent (50%) of the rollout-targets set out in the roll-out obligation prior to the second anniversary of the first proposed launch of the service is considered non-utilisation and will result in the radio frequency spectrum licence withdrawal.

7.2	A licensee must ensure that the appointed signal distributor distributes 15% of MUX 1 capacity that is assigned by the Authority pursuant to the issue of this spectrum licence.
7.3	A licensee must ensure that the appointed signal distributor, through a commercial arrangement and without prejudice, distributes 85% of MUX 1 capacity that is assigned by the Authority to SABC.
7.4	Fifteen percent (15%) of the MUX 1 Digital Terrestrial Television Distribution network must be completed prior to second anniversary of the first proposed launch of the service.
7.5	The Authority shall review the radio frequency spectrum utilisation by the licensee two (2) years after ASO.
7.6	A licensee must submit to the Authority - prior to the second anniversary of the launch of the service - a declaration: <ul style="list-style-type: none"> <li>a) indicating that the services are being provided; and</li> <li>b) detailing the extent of the network roll-out</li> </ul>

## 8. GENERAL CONDITIONS
