## **SCHEDULE**

### **DEFINITION**

1. In this Schedule “the Directions” means the Electronic Communications, Postal and Broadcasting Directions published in *Government Gazette* No.43164, Government Notice No. 417 of 26 March 2020, as amended by Government Notice No. 451 of 6 April 2020.

### **AMENDMENT OF PARAGRAPH 2 OF DIRECTIONS**
