I, Ebrahim Patel, Minister of Trade, Industry and Competition hereby propose to extend the Tshwane Automotive Special Economic Zone (Gazette No: 42956), in terms of the Special Economic Zones Act No. 16 of 2014.

The proposed extension includes a portion of Phase 3, which land area is situated in between Phase 1 and 2 of the Special Economic Zone, located in Silverton, east of the City of Tshwane. The total land area of the extension is 10.2 ha.


The proposed Tshwane Automotive SEZ extension comprises, Phase 3, portion 769 on The Willows 340 JR, borders Alwyn Road in the North, to the East and South by erf PtnR 601 and Prop Shaft Road to the West.

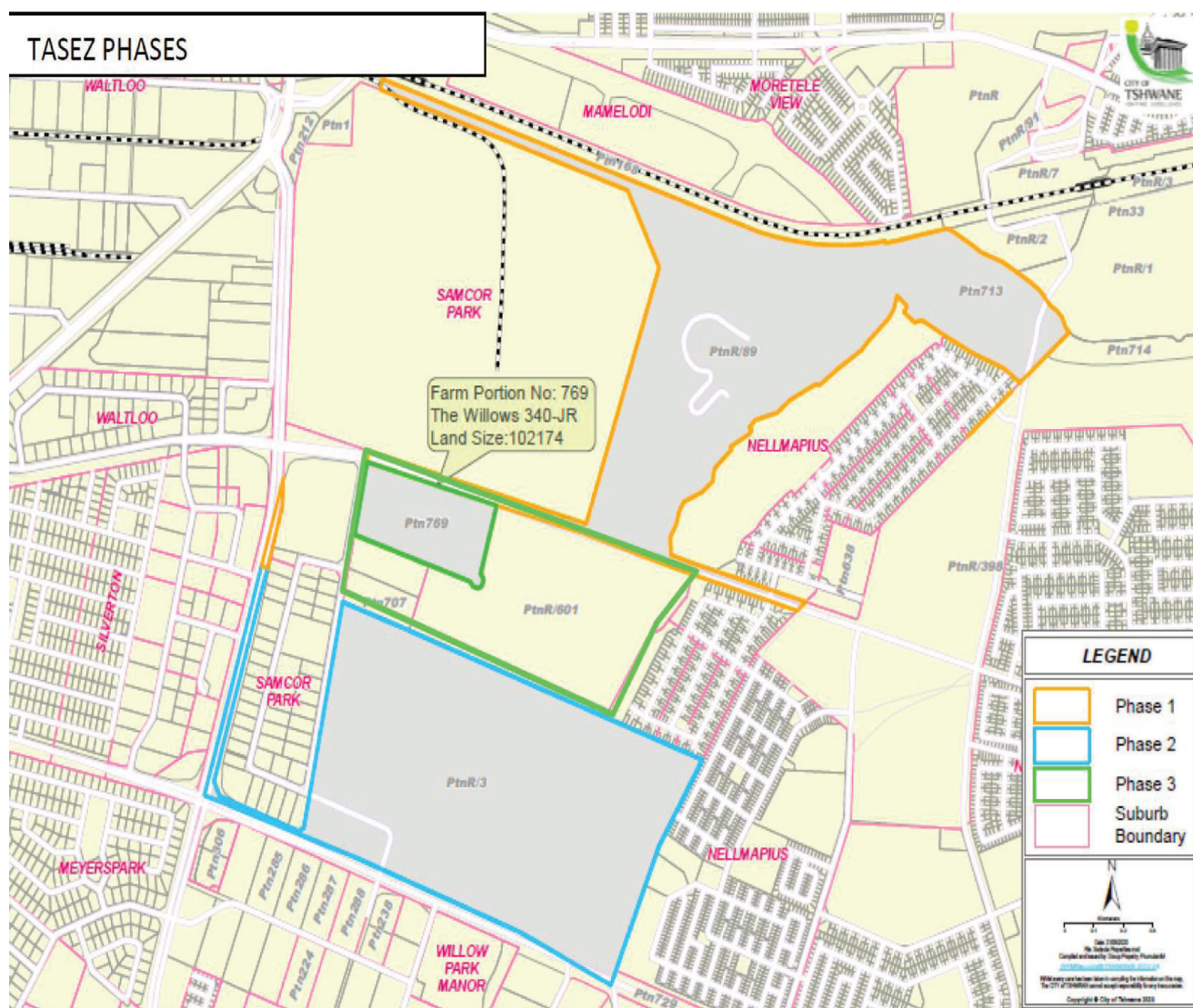
